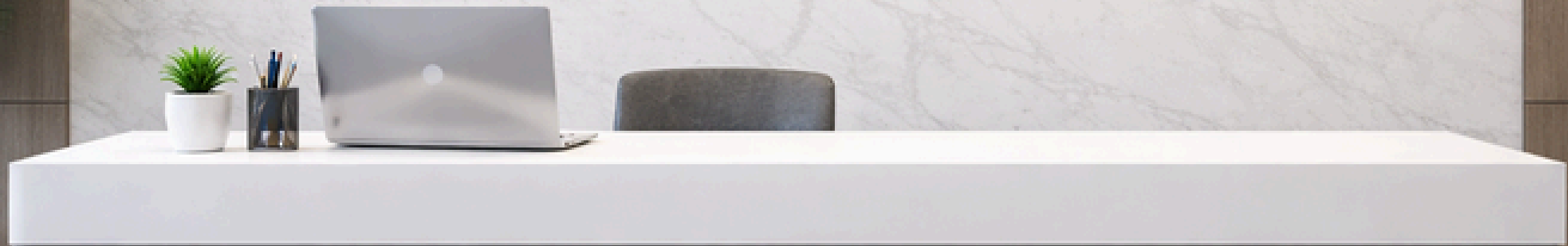

## 1. Sourcing Project Service

We provide end-to-end sourcing solutions to help businesses identify suitable suppliers, verify credibility, and negotiate competitive pricing.

### Scope of Service

- Supplier identification & verification

### Fee Structure

#### Fixed Service Fee:

- RMB 2,160 (USD 300)

#### Commission Structure:

- 2% on orders up to RMB 100,000
- 1.5% on orders between RMB 100,000 - RMB 1,000,000
- 1% on orders above RMB 1,000,000

## 2. Regular Running Order Management

### Monthly Service Fee
